

1. **तरूण कुमार बोकारो** स्टील सिटी, झारखंड, ग्राम भतुआ, पोस्ट बैधमारा, बोकारो स्टील सिटी के रहने वाले हैं। वह और उनका परिवार 22 जून, 2023 को मेरे घर आए थे। उन्होंने शायद उस समय कार्य से छुट्टी ली थी और संपत्ति के लालच में मेरे पति पर देवर (मेरे पति के भाई) के साथ हमला किया था।

2. **मेरे बच्चे घर से बाहर** रहते थे। घर पर हम 5 सदस्य रहते थे। हमने सिविल और आपराधिक अदालतों के रूप में पुलिस स्टेशन और अदालत में शिकायतें दर्ज कीं। हर महीने, श्री तरूण उनके परिवार (पिता, माता, आदि) को अपनी उपस्थिति बताने के लिए अदालत आते हैं। वह जून से आ रहे हैं। मामला अभी भी चल रहा है। आईपीसी धारा में (147, 0148, 149, 323, 341, 325, 326, 427, 452, 354, 279, 504, 506, 34), 506, 34) आदि शामिल हैं। केस फाइलिंग संख्या: 1292/2023।

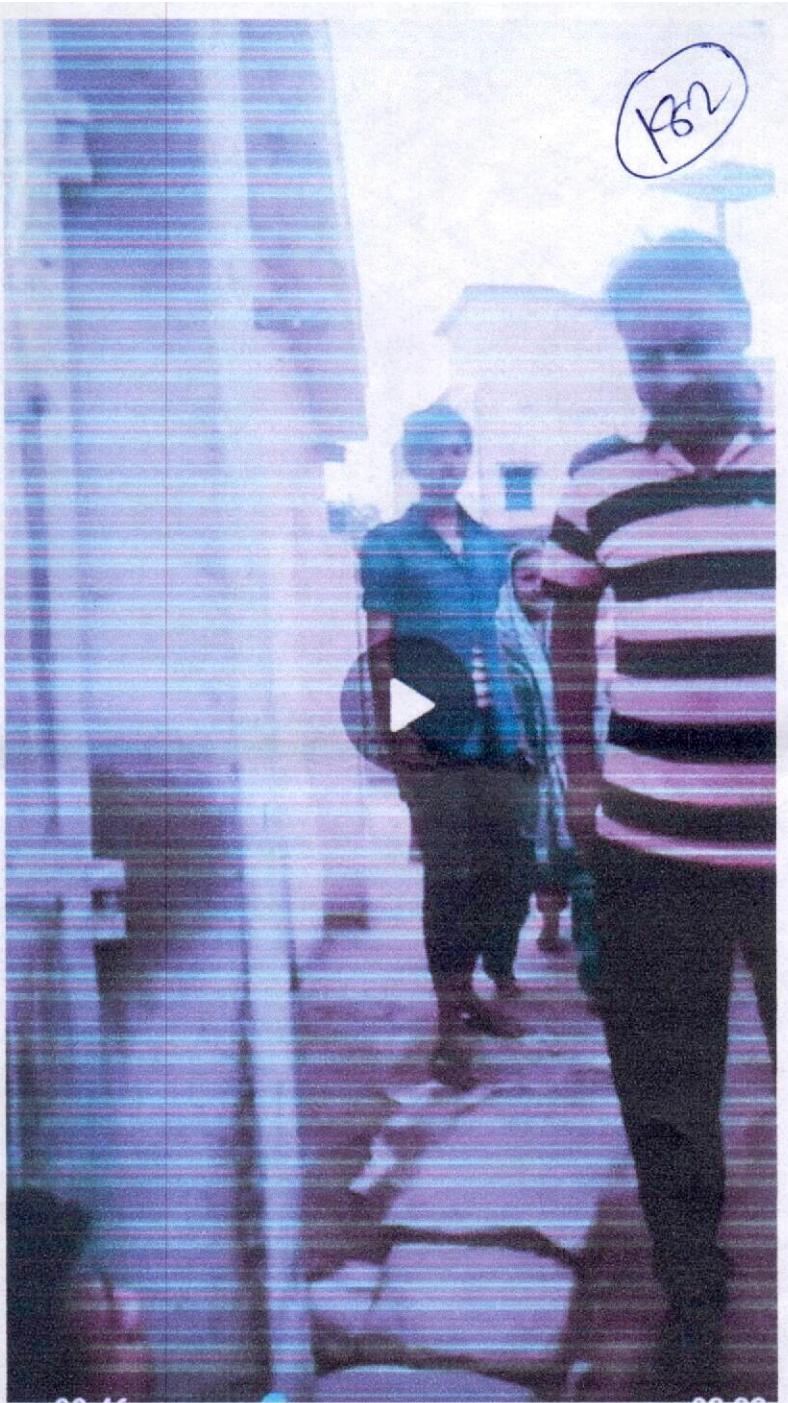
मेरा मानना है कि बंशीधर कुम्भकार के पुत्र श्री तरूण कुमार के कार्य, [भ्रष्टाचार निवारण अधिनियम 1988, विनियम, या आचार संहिता] का उल्लंघन हो सकते हैं। इस तरह का व्यवहार न केवल ईमानदारी को कमजोर करता है बल्कि सरकार पर जनता का भरोसा भी कम करता है।

- 3. We used to take Rashaan as provided by the Government of India from Kota. Tarun works in the PDS department. He targeted our family and created obstacles always to not get rashaan from Kota. He torched a lot. He leaked our data to an unknown person. He took advantage of their position to target us and cause us a lot of problems. Name of Kota: Village Bhatua, Bokaro Steel City, Jharkhand, 827009**
